D.C. Bar Pro Bono Center Executive Director Neptune reported that Mayor Bowser's proposed FY 25 budget significantly reduces funding for access to justice programs and could have a serious impact on the Pro Bono Center. President Lowery and Executive Director Neptune will testify before the Council of the District of Columbia to advocate for an increase in access to justice funding.

Chief Programs Officer Sobin and Immediate Past President Ellen Jakovic reported that the recent travel abroad program to Portugal was a success, offering attendees nine hours of continuing legal education credits.

Chief Programs Officer Sobin also reported that the 2024 Payton Leadership Academy begins this month.
